Randy Sweet advised the Board that the next meeting is a tour of the Boone Creek River Walk on July 7, 2019. The spring cleanup event went very well; they had over 30 volunteers and pulled out a great deal of trash.

# 7.3 Field Superintendent

Field Superintendent Rob Bowman informed the Board:

- The field crew has been working on bog removal
- Flood debris calls have been averaging 5-6 per day; lots of debris and they have limited access to the lower river due to lock & dam construction; be careful.
- The dirt field is operational (currently operating at 70% due to recent rain)
- Received 5 watershed proposals; will be reviewing next week
- The water portion of the Fox Lake Triathalon scheduled for 6/2/2019 is tentative depending on water conditions
- The buoys will all be in position by the end of next week
