Silt fences have been installed and gravel roadways are being created; should be up and running by Spring. On the Wharf project, everything is moving along. They are working on installing the fuel pad systems.

The Advisory Committee feels there is a need for an education program; looking to put together an informational/educational video. Attended the Fox River planning meeting. Southeastern WI Fox River Commission is hosting a summit on March 26. Director Stochl and Randy Sweet met with Fox Lake regarding the 501c3; the meeting went well.

Field Superintendent Rob Bowman informed the Board:

- 285 loads removed from Pedersen; around 35% completed (only been onsite working 14 full days due to weather)
- Ackerman Island: 506 loads have been removed, 60-65% complete on cleaning it out
- Multiple reports of a sand berm in Nippersink Creek

# 9.0 Public Comments and presentations

- **Dorothy Wenzel (Cary, IL):** In all the years since inception of the Agency, they have been involved with the Agency, she was unaware of the Antique Boat classification. Also wondered what the lobbyist does.
- Jim Cistaro (Jackson Dr.): Was in favor of the lobbyist providing a report of their activities; was supportive of extending the termination length. RDS Charity is hosting another event for the Arts & Sciences at Studio Hot Rods.
- **Jeff Lang (Southeastern WI Fox River Commission):** Hosting a summit on March 26<sup>th</sup>. There will be a presentation regarding covered crops from a farmer who has adopted the principal and has saved millions of dollars by doing so. Waukesha Water Diversion is still 2.5 years out; could lead to a reduction in 10 million gallons of water per day.
- Susan Riley (Sibley Dr., Antioch): Wants to get more involved with the chain and Agency; likes the idea of the lobbyist but feels we need to seek a proposal for a lobbyist, feels strongly we need a report, and need to provide a list of what we need the lobbyist to do. Has an issue with her property (Lake County changed their drainage system and it's now draining onto personal properties). Antioch Golf Course is dumping water from their pond onto her property. Would like to see an official list of the dredging projects and status.
