Commercial Waterway User Sticker Application

Chapter 4, Sections 4.01 and 4.02B of the Fox Waterway User Permit Sticker Regulations state that it is unlawful for any person to engage in Commercial Operations on the Fox Waterway without first having obtained a Commercial Waterway User Sticker.

To apply for a Commercial User Sticker, complete and submit this Application with all required attachments through the Agency's online platform or in person at the Fox Waterway Agency's office. All sections of this application must be filled out truthfully and in their entirety. If a Section does not apply to you, mark "N/A". Incomplete forms will not be accepted or processed by the Agency. It is unlawful for any business to provide false or fictitious information on record related to your registered vessels.

6. USER FEE SCHEDULE- COMMERCIAL ENDORSEMENT. (Ch.4, Sections 4.02B; 4.03)

Commercial vessels, including work boats, are classified using the same boat class letters as recreational vessels. All Commercial Watercraft must have a Waterway sticker for the appropriate boat class with a **Commercial Endorsement** for Commercial Boat Operations. For Dealer Watercraft, the User Fee is a flat fee of \$250.00. For all other Commercial Watercraft, the User Fee is twice the Recreational Boat Class Rate B, C, E, or X; based on length.
